





Information for doctors on cannabis-based products for medicinal use (CBPMs)

Following legislative changes, from 1 November 2018, cannabis-based products for medicinal use (CBPMs) can be prescribed across the UK. Lidocaine Patches now RED on the Rotherham CCG Traffic Light System

The Rotherham Foundation Trust (TRFT) and Rotherham CCG have agreed that Lidocaine patches are now RED (hospital issue only) for any indication other than postherpetic neuralgia (the only licensed indication).

Clinicians are advised to refer any **new** patient back to original prescriber for continuation of supply.

NHS England Medicines Optimisation in Care Homes (MOCH) Project

As part of a two year NHS England project, South Yorkshire and Bassetlaw Integrated Care System has set up a new MOCH team consisting of pharmacists and pharmacy technicians. This Team is employed by NHS Sheffield CCG with the aim of improving the care home resident's overall quality of life by looking at medication and any other issues that they may have, such as with diet or their lifestyle, and working with care homes to look at resolving these issues.

Richard Daniszewski (Pharmacist) and Gilly Sharp (Pharmacy Technician), will be starting to visit care homes in NHS Rotherham CCG, and will be contacting GP practices aligned to those care homes in due course, to discuss clinical systems access and ways of working.

Reports of prescriptions for Epipen no longer being able to be sent to pharmacies electronically It has been reported by some SystmOne GP practices that prescriptions for Epipen / Emerade / Jext that

used to be sent via Electronic Transfer of Prescriptions (ETP) are now unable to be sent and require the prescription to be printed. This issue has occurred due to a change in how Epipen is listed in the SystmOne drug library.
