Hypromellose eye drop changes

Hypromellose has been moved from the "drug" section of the Drug Tariff to the "appliance" section. Therefore, it is now necessary to prescribe Hypromellose as a specific brand to guarantee a low price. Additional to this, our formulary choice of preservative-free Hypromellose has been recently discontinued. Going forward we recommend a choice of 2 options for both standard and preservative free Hypromellose. Having multiple options should help to reduce problems with further out-of-stocks. OptimiseRx has also been updated with the options below.

Mild dry eye (<4 drops a day) Consider self-care

 Aaculose or Aapromel Hypromellose 0.3% eye drops 10 mL

Moderate dry eye (4-6 drops a day)

 Xailin Hydrate or Tear-Lac Hypromellose 0.3% eye drops, preservative free 10 mL

Valproate Annual Risk Acknowledgement Form (VARAF) process aid for Epilepsy Patients under the care of SCH/STH.

The MMT has produced a flow chart to aid practices meet the requirements surrounding the use of valproate in epilepsy. Please note that in this first instance, the MMT has already contacted the Sheffield epilepsy service for those patients that have been seen within the last 5 years (as denoted by the box) and added the "referral for completion of VARAF" Read-Code to practice systems. The Epilepsy service has confirmed that for these patients, the VARAF will be completed and sent to practices.
